TOCETHER with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, including all built-in stoves and refrigerators, heating, air conditioning, plumbing and electrical fixtures, wall to wall carpeting, fences and gates, and any other equipment or fixtures now or hereafter attached, connected or fitted in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than bousehold furniture, be considered a part of

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute; that the above described premises are free and clear of all liens or other encumbrances; that the Mortgagor is lawfully empowered to convey or encumber the same, and that the Mortgagor will forever defend the said premises unto the Mortgagor, its successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

THE MORTGAGOR COVENANTS AND AGREES AS FOLLOWS:

- t. That the Mortgagor will promptly pay the principal and interest on the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- 2 That this mortgage will secure the Mortgageo for any additional sums which may be advanced hereafter, at the option of the Mortgageo for the payment of taxes, or public assessments, hazard insurance premiums, repairs or other such purposes pursuant to the provisions of this mortgage, and also for any loans or advances that may hereafter be made by the Mortgageo to the Mortgagor under the authority of Sec. 45-55, 1902 Code of laws of South Carolina, as amended, or similar statutes; and all sums so advanced shall bear interest at the same rate or rates as that provided in said note unless otherwise agreed upon by the parties and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- I that Mortgagor will keep the improvements on the mortgaged premises, whether now existing or hereafter to be erected, insured or nost loss by tire windstorm and other hazards in a sum not less than the balance due hereunder at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor does hereby assign the policy or policies of insurance to the Mortgagee and acceptable to the Mortgagee and Mortgagee should it so require and shall include loss payable clauses in favor of the Mortgagor and in the event of loss. Mortgagor will give immediate notice thereof to the Mortgagee by registered muil; and should the Mortgagor at any time fail to keep said premises insured or fail to pay the premiums for such insurance, then the Mortgagee may cause such improvements to be insured in the name of the Mortgagor and reunburse itself for the cost of such insurance, with interest as here malower provided.

- That if this mortgage secures a "construction loan", the Mortgagor agrees that the principal amount of the indebtedness hereby secured shall be disbursed to the Mortgagor in periodic payments, as construction progresses, in accordance with the terms and conditions of a Construction Loan Agreement which is separately executed but is made a part of this mortgage and incorporated herein by reference.
- S. That the Mortgagor will not further encumber the premises above described, without the prior consent of the Mortgagee, and should the Mortgagor so encumber such premises the Mortgagee may at its option, declare the indebtedness hereby secured to be immediately the and payable and may institute any proceedings necessary to collect said indebtedness.
- 9 That should the Mortgagor alienate the mortgaged premises by Contract of Sale, Bond for Title, or Deed of Conveyance, and the within mortgage indebtedness is not paid in full, the Mortgagor or his Purchaser shall be required to file with the Association an application for an assumption of the mortgage indebtedness, pay the reasonable cost as required by the Association for processing the assumption burnish the Association with a copy of the Contract of Sale, Bond for Title, or Deed of Conveyance, and have the interest rate on the loan balance existing at the time of transfer modified by increasing the interest rate on the said loan balance to the magnitum rate per annun permitted to be charged at that time by applicable South Carolina law, or a lesser increase in interest rate as may be determined by the Association. The Association will notify the Mortgagor or his purchaser of the new interest rate and monthly payments and will mad him a new passbook. Should the Mortgagor, or his Purchaser, fail to comply with the provisions of the within paragraph the Mortgagee at its option, may declare the indebtedness hereby secured to be immediately due and payable and may institute any proceedings necessary to cullect said indebtedness.
- 10 That should the Mortgagor fail to make payments of principal and interest as due on the promissory note and the same shall-be unused for a period of thirty (30) days or if there should be any failure to comply with and abide by any by-laws or the charter of the Mortgagor or any stipulations set out in this mortgage the Mortgagor at its option may write to the Mortgagor at his last known address giving him thirty (30) days in which-to rectify the said default and should the Mortgagor fail to rectify said default within the said that y days the Mortgagor may at its option, increase the interest rate on the loan balance for the remaining term of the loan or for a lesser term to the maximum rate per annum permitted to be charged at that time by applicable South Carolina law, or a lesser increase rate as may be determined by the Association. The monthly payments will be adjusted accordingly.

That should the Mortgagor tail to make payments of principal and interest as due on the promissory note and should any monthly installment become past due for a period in excess of 15 days, the Mortgagee may collect a "late charge" not to exceed an amount equal to five (542) per centum of any such past due installment in order to cover the extra expense incident to the handling of such delinquent payments
- 12 That the Mortgagor hereby assigns to the Mortgagoe, its successors and assigns, all the rents, issues, and profits accruing from the mortgaged precises, retaining the right to collect the same so long as the debt hereby secured is not in arriers of payment, but should any part of the principal indebtedness, or interest, taxes, or fire insurance premiums, be past due and unpaid, the Mortgagoe may without notice or further proceedings take over the mortgaged premises, if they shall be occupied by a tenant or tenants, and collect said rents and profits and apply the same to the indebtedness hereby secured, without liability to account for anything more than the rents and profits actually collected, less the cost of collection; and any tenant is authorized, upon request by Mortgagoe, to make all rental payments direct to the Mortgagoe, without liability to the Mortgagor, until notified to the contrary by the Mortgagoe, and should said profitses at the time of such default be occupied by the Mortgagor, the Mortgagoe may apply to the Judgo of the County Courter to any Judgo of the Court of Common Pleas who shall be resident or presiding in the county after paying the cost of collection, to the mortgago debt without liability to account for anything more than the rents, and profits actually collected.
