NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby exhowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville:

All those pieces, parcels or lots of land situate, lying and being on the southwesterly side of Carver Road in Chick Springs Township, Greenville County, South Carolina, being shown and designated as Lot 18 and the southerly and adjoining one-half of Lot 17 according to plat of property of Lily McC-Loftis, prepared by Terry T. Dill, R.L.S., February 23, 1961, as recorded in Plat Book GGG, Pages 456 and 457, RMC Office, Greenville County, South Carolina, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwesterly side of Carver Road at joint front corner of Lots 18 and 19 and running thence along the joint line of the said Lots S. 56-00 W. 167 feet to an iron pin at the joint rear corner of the said lots; thence N. 34-00 W. 135 feet to an iron pin at the center point on the rear line of Lot 17; thence on a straight line through the center of Lot 17 N. 56-00 E. 167 feet to an iron pin at the center point on the front line of Lot 17 on the southwesterly side of Carver Road; thence along said Carver Road S. 34-00 E. 135 feet to an iron pin at the point of beginning.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagor forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
