It is hereby agreed, that should any default be rade in the payment of interest on said first norigage, and such interest resains unpaid and in arrears for ten days, or should any suit be correnced to foreclose said first rortgage, then the enount secured by this mortgage and the accompanying note shall become and te due and payable at any time thereafter at the option of the owner or holder of this nortgage.
