

"ALL that certain piece, parcel or let of land, with all improvements thereon, or bereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Greenville, near the City of Greenville, situate on the Northeast side of Greenland Drive and being shown as Lot numbers 39 and 40 on a plat of Pleasantburg Forest, made by Dalton & Neves, Engineers, August 1956, with addition thereto dated January 1961, recorded in the R.M.C. Office for Greenville County, S.C., in Plat Book GG, page 162, and having according to said plat, the following metes and bounds, to-wit:
