NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot No. 110, Berea Porest, Sec. II, and having, according to a plat recorded in the RMC Office for Greenville County, South Carolina, in Plat Book 4N, at Pages 76 and 77, the following courses and distances, to-wit: BEGINNING at a point on the edge of Berea Porest Circle, joint front corner of Lots Nos. 109 and 110, and running thence with said road, S. 29-45 W. 90 feet to a point, joint front corner of Lots Nos. 110 and 111; thence with the common line of said lots, N. 60-15 W. 130 feet to a point; thence, N. 29-45 E. 90 feet to a point; thence with the common line of Lots Nos. 110 and 109, S. 60-15 E. 130 feet to a point on the edge of Berea Forest Circle, the point of beginning.
