NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 360 as shown on a plat of Del Norte Estates, Section III, prepared by Piedmont Engineers and Architects May 9, 1971, recorded in the RMC Office for Greenville County in Plat Book 4-N at Page 14 and 15, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Sherborne Road, joint front corner of Lots 360 and 361, and running thence with the joint line of said lots, S. 35-29 W. 135.0 feet to an iron pin; thence S. 44-31 E. 121.8 feet to an iron pin at the corner of property now or formerly of R. C. Jones; thence with the line of R. C. Jones property, N. 27-20 E. 157.8 feet to an iron pin on the Southern side of Sherborne Road; thence with said Road, N. 54-31 W. 97.8 feet to the point of beginning.
