And said martgager across to keep the landing and in provements now standing or love it and college to the control profises and apparatus, fixtures and appartenances now or beteafter in or attailed to end hadrings or increase and its instituted against loss or duringe by fire and such other hazards as the martgager may from time to their require, all so hadrance to be in forms, in companies and in sums (not less than sufficient to avoid any chim on the part of the insurers for co-insurance) satisfactory to the mortgager; that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgager, and that at least fifteen days before the expiration of each such policy, a new and sufficient policy to take the place of the one so expiring shall be delivered to the mortgager.
