NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and

designated as Lot No. 126, Merrifield Park, as shown on plat thereof recorded in the BMC Office for Greenville County, S. C., in Plat Book 000, Page 177, and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the southwestern side of Merrifield Drive, corner of Lot 137 and running thence with southwestern side of Merrifield Drive, S. 14-18 E. 110 feet to corner of Lot 125; thence with line of said lot, S. 55-42 W. 232.4 feet to an iron pin in line of lot 134; thence with lot 134, N. 52-27 W. 115.8 feet to an iron pin in line of lot 138; thence with lot 137 and 138, N. 55-42 E. 268.5 feet to beginning corner.
