

All that certain piece, parcel or lot of land, with all improvements thereon, or bereafter constructed thereon, situate, bying and being in the State of South Carolina, County of Greenville. On the northern side of Cavies Point Road being shown and designated as Lot # 439 on a plat of Section V, well North Estates proper d by Pindmont Engineers and Architects dated May 23, 1973 recorded in Plot Book 4R at Page 17 in the R. M. C. Office for Greenville County and being described according to said plat more particularly to-wit:
