Greenville, South Carolina, hereinafter called the Mortgagor, is indebted to

, a corporation organized and existing under the laws of the State of South Carolina, hereinafter called Mortgagee, as evidenced by a certain promissory note of even date herewith, the terms of which are incorporated herein by reference, in the principal sum of Twenty-seven Thousand One Hundred and no/100ths ----- Dollars (\$ 27,100.00), with interest from date at the rate of eight & three-fourths per centum (8-3/4%) per annum until paid, said principal and interest being payable at the office of AIKEN-SPEIR, INC., P. O.
