- (1) That this mortgage shall secure the Mortgagee for such further sums as nay be a branced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes purvaint to the conceants hereby. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made howarder to the Mortgager by the Mortgagee so long as the total indebtness thus secured does not exceed the original amount shown on the face hereof.
