Dollars as evidenced by Mortgagor's promissory rate of even date herewith, which rate does not contain a provision for escalation of interest rate a paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

Thirteen and 81/100----- 313.81 Dollars each on the first day of each month hereafter in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment of not sooner paid, to be due and payable 30

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a person of thirty days, or if there shall be any failure to comply with and abode by any By-Laws or the Charter of the Microspee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said generals due, and interest, with costs and expenses for proceedings; and

All that certain piece, parcel, or lot of bed, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of South Carolina Highway No. 143 and the northwestern side of Kingswood Circle and being known and designated as Lots Nos. 2 and 3 of KINGSWOOD Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-X at 18 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin on the northwestern side of Kingswood Circle, joint front corner of Lots 3 and 4 and running thence N.57-38 W. 365.5 feet to an iron pin; thence N.30-06 E. 461.6 feet to an iron pin on the southern side of South Carolina Highway No. 143 and running thence with said Highway, S.67-07 E. 200 feet to an iron pin; thence S.29-48 W. 298.2 feet to an iron pin; thence S.59-28 E. 196.8 feet to an iron pin on the northwestern side of Kingswood Circle; thence with said Street, as follows: S.30-C6 W. 30 feet; S.32-44 W. 50 feet; S.43-40 W. 125 feet to the point of beginning.
