Now, Know All Man, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagoe, its successors and assigns, the following-described property situated in the county of Greenville

State of South Carolina;

ALL that piece, parcel or lot of land, together with all buildings and improvements, situate, lying and being on the northeastern side of Woodland Drive, in Greenville County, South Carolina, being the northeasternmost portion of Tract No. 34 on a Map of MOUNTAIN VIEW ACRES, made by Dalton & Neves, Surveyors, dated April, 1937, and recorded in the RMC Office for Greenville County, S. C., in Plat Book I, pages 69 and 70, and having according to a more recent plat of the Property of Edgar Lyle Midkiff and Neal R. Midkiff, made by Freeland & Associates, dated May 31, 1976, the following metes and bounds, to-wit:
