Dollars as evidenced by Mortgagor's promissory note of even date herewith, which note a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of

One Handred Twenty Five and 97/100-----(\$ 125.97) Dollars each on the first day of each month bereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not some ... years after date; and paid, to be due and payable 20

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any fadure to comply with and abide by any By-Laws or the Charter of the Mortgager, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaborate given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may bereafter become indebted to the Mortgagoe for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose:

NOW, KNOW ALL MFN. That the Meetgages, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Meetgages to the Meetgages's account, and also in consideration of the sum of Three Deliars (\$3.00) to the Meetgages in hand well and truly paid by the Meetgages at and before the scaling of these presents, the receipt whereof is hereby advandedged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Meetgages, its successors and assigns, the following described real estate:

All that certain piece, parcel or lot of land, with all improvements therein, or hereafter to be constructed thereon, situate, hing and being in the State of South Carolina, County of Greenville, in the City of Greenville and on the East side of Belmont Avenue (forcerly Hallet Avenue) and having the following metes and bounds, to-wit:

REGINNING at an iron pin on Belmont Avenue (formerly Hallet Avenue), common corners of this lot and the lot now or formerly belonging to McIver, and running thence with said avenue, N. 3 E. 125 feet to an iron pin; thence N. 85 W. 165 feet to am iron pin; thence S. 3 W. 125 feet to am iron pin; thence S. 85 E. 165 feet to the beginning corner.
