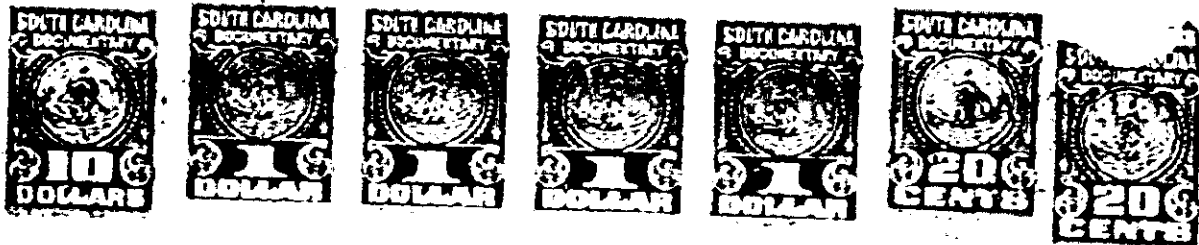
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near Hellams Crossing, containing 41.21 acres, more or less, as shown on plat of Robert S. Wolgemuth recorded in plat book RRR, page 113, and having the following metes and bounds, to-wit:

Beginning at an iron pin at the tract's northeastern corner, at Buchanan, and running thence S 12-18 E 2,229.4 feet to an iron pin at Banks, thence N 79-15 W 1,165.8 feet to an iron pin at Lineberger; thence N 2-15 E crossing Lindsey Lake Road 2,024.2 feet to Miller; thence S 84-00 E 594 feet to the point of beginning.

This property is subject to a right-of-way to the City of Greenville for a water line, fifty feet in width, as shown in deed book 607, page 348.
