(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Sixteen Thousand and no/100ths----- DOLLARS

(\$ **16,000.00**), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is **twenty** years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, **City of Greenville,** being known and designated as Lot No. 10 of North Park Addition, according to Plat of Dalton & Neves, April 1941, recorded in Plat Book K, page 89, R.M.C. Office for Greenville County, and being more particularly described as follows:

BEGINNING at a stake on the south side of Gallivan Street, corner of Lot No. 9, and running thence with said Lot S. 24-30 W. 178 feet to stake in branch; thence down and with the meanderings of said branch 88.2 feet, more or less, to stake; thence N. 13-0 E. 166 feet to stake on said street; thence with said street N. 65-30 W. 55 feet to the beginning.
