two and 66/100 ----- (\$ 292.66 ) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date: and

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville situate on the eastern side of Camelot Drive in the County of Grenville, State of South Carolina, being shown as Lot No. 18 on a plat of Woodall Subdivision dated January 8, 1976, prepared by C. O. Riddle, Surveyor, recorded in Plat Book 5-P at page 12 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Camelot Drive at the joint front corner of Lot 17 and Lot 18 and running thence with Lot 17 S. 87-57 E. 130.7 feet to an iron pin at the joint rear corner of Lot 17 and Lot 18; thence with a branch, the center line of the branch being the property line N. 41-22 E. 50.4 feet to an iron pin; thence still with said branch N. 53-42 W. 124.4 feet to an iron pin; thence S. 68-13 W. 60.5 feet to an iron pin on the eastern side of Camelot Drive; thence with said drive S. 5-01 W. 45 feet to an iron pin; thence with said drive S. 5-22 W. 39.7 feet to the point of beginning.
