MODIFICATION & ASSUMPTION AGREEMENT

STATE OF SOUTH CAROLINA  
 COUNTY OF GREENVILLE

Loan Account No. 18942

WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, hereinafter referred to as the ASSOCIATION, is the owner and holder of a promissory note dated Oct. 29, 1971, executed by Charles J. Strickland, transferred to Raymond F. & Betty Lyles in the original sum of \$ 18,000.00 bearing interest at the rate of eight % and secured by a first mortgage on the premises being known as Lot 285 Woodfields, Section b, South Beaver Lane, which is recorded in the RMC office for

Greenville County in Mortgage Book 1211, page 649, title to which property is now being transferred to the undersigned OBLIGOR(S), who has (have) agreed to assume said mortgage loan and to pay the balance due thereon; and WHEREAS the ASSOCIATION has agreed to said transfer of ownership of the mortgaged premises to the OBLIGOR and his assumption of the mortgage loan, provided the interest rate on the balance due is increased from eight % to a present rate of nine %, and can be escalated as hereinafter stated.

NOW, THEREFORE, this agreement made and entered into this 15 day of June, 1976, by and between the ASSOCIATION, as mortgagee, and ~~James Sabbo~~ Jannie J. W. Sabb, as assuming OBLIGOR,

WITNESSETH:

In consideration of the premises and the further sum of \$1.00 paid by the ASSOCIATION to the OBLIGOR, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the loan balance at the time of this assumption is \$ 16,741.30; that the ASSOCIATION is presently increasing the interest rate on the balance to nine %. That the OBLIGOR agrees to repay said obligation in monthly installments of \$ 150.71 each with payments to be applied first to interest and then to remaining principal balance due from month to month with the first monthly payment being due July 1, 1976.

(2) THE UNDERSIGNED agree(s) that the aforesaid rate of interest on this obligation may from time to time in the discretion of the ASSOCIATION be increased to the maximum rate per annum permitted to be charged by the then applicable South Carolina law. Provided, however, that in no event shall the maximum rate of interest exceed nine ( 9 ) % per annum on the balance due. The ASSOCIATION shall send written notice of any increase in interest rates to the last known address of the OBLIGOR(S) and such increase shall become effective thirty (30) days after written notice is mailed. It is further agreed that the monthly installment payments may be adjusted in proportion to increments in interest rates to allow the obligation to be retired in full in substantially the same time as would have occurred prior to any escalation in interest rate.

(3) Should any installment payment become due for a period in excess of (15) fifteen days, the ASSOCIATION may collect a "LATE CHARGE" not to exceed an amount equal to five per centum (5%) of any such past due installment payment.

(4) That all terms and conditions as set out in the note and mortgage shall continue in full force, except as modified expressly by this Agreement.

(5) That this Agreement shall bind jointly and severally the successors and assigns of the ASSOCIATION and OBLIGOR, his heirs, successors and assigns.
