ALL that certain piece, parcel or tract of land in the State of South Carolina, County of Greenville, in Fairview Township, being shown as 2.025 acres on plat entitled "Property of Rev. Roy Fleming", prepared by J. L. Montgomery, III, dated August 13, 1976, recorded in the RMC Office for Greenville County in Plat Book 5V at page 84 , and having, according to said plat, the following metes and bounds, to wit:
