All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as

Lot Number 102 on plat of Canebrake I, recorded in Plat Book 5-D at Pages 95 and 96 of the RMC Office for Greenville County, and having according to said plat the following metes and bounds, to-wit:
