All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 221, Sunny Slopes Subdivision, Section IV, according to a plat prepared of said Subdivision by C. O. Riddle, Surveyor, August 19, 1976, and which said plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 5-P, at Page 52, and according to said plat having the following courses and distances, to-wit;

BEGINNING At a point on the edge of Duncan Road, joint front corner of Lots 221 and 222, and running thence with said Road, S. 0-21 E. 65.5 feet to a point on the edge of said Road; thence running with a branch as the line, the traverse being S. 32-39 E. 69.4 feet; thence running with the common line of property now or formerly owned by Grandview Cemetery, N. 45-39 W. 425.5 feet to a point, joint rear corner of Lots 217, and 221; thence running with the common line with Lot 217, N. 41-04 E. 120.5 feet to a point, joint rear corner of Lots 217, 218, 221 and 222; thence running with the common line with Lot 222, S. 44-43 E. 371.9 feet to a point on the Edge of Duncan Road, the point of Beginning.
