WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northern side of East Sable Court, being shown and designated as Lot No. 20 on a plat of Blue Mountain Park subdivision, made by James M. Beeson dated March 15, 1955, recorded in the R. M. C. Office for Greenville County, South Carolina, in Plat Book EE, at page 121, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northern side of East Sable Court at the joint front corner of Lots Nos. 19 and 20, and running thence with the common line of said lots, N. 60-30 E., 160 feet to an iron pin; thence N. 29-30 W., 493.3 feet to an iron pin; thence along the common line of Lots Nos. 20 and 21, S. 27-42 W., 217 feet to an iron pin on the northern side of East Sable Court; thence along the curve of the northern side of East Sable Court, 80.1 feet to an iron pin, the point of BEGINNING, said curve having a radius of 140 feet.

The above described property is the same conveyed to the mortgagors herein by deed of George Clayborn Sentell, to be recorded herewith.

In addition to and together with the monthly payments of principal and interest under the terms of the note secured hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
