NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of fand, situate, lying and being on the Northern side of Rollingreen Road, near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 49 as shown on a plat entitled "Wellington Green", dated October 11, 1961, prepared by Piedmont Engineering Service, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY at Page 29, and having, according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the Northern side of Rollingreen Road at the joint front corner of Lots No.s 49 and 50 and running thence with the line of Lot No. 50, N. 30-44 E., 179.2 feet to an iron pin in the line of Lot No. 41 at the joint rear corner of Lots Nos. 49 and 50; thence with the line of Lot No. 41, S. 61-39 E., 34.0 feet to an iron pin at the joint rear corner of Lots Nos. 41 and 42; thence with the line of Lot No. 42, S. 57-23 E., 66.0 feet to an iron pin at the joint rear corner of Lots Nos. 48 and 49; thence with the line of Lot No. 48, S. 30-44 W., 178.4 feet to an iron pin on the Northern side of Rollingreen Road at the joint front corner of Lots Nos. 48 and 49; thence with the Northern side of Rollingreen Road N. 59-16 W., 100.0 feet to the point of beginning.

In addition to and together with the monthly payments of principal and interest under the terms of the Note secured hereby, the mortgager promises to pay to the mortgage a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secured by the mortgage if the mortgagor fails to pay it.
