NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his accounts by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Glassy Mountain Township, near Oak Grove Church and described as follows:

Being Lot B as shown on plat made for Edgar L. & Kathy H.Atkins by James V.Gregory, R.L.S. September 9,1977 showing courses and distances as follows:

Beginning on an iron pin near center of Pittman Road about ½ mile East of S.C.Highway No.116 and running N. 41-54 E. 440.6 feet to an iron pin; thence S.40-20 E. 120.2 feet to an iron pin at line of Lot A; thence with line of Lot A ,S.41-54 W. 410.3 feet to an iron pin in Pittman Road; thence with center line of Pittman Road N.54-49 W.120 feet to the beginning, containing 1.16 acres, more or less.
