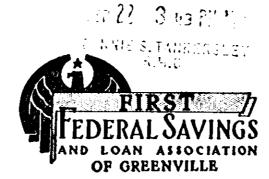

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW. KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville and being known and designated as a portion of Lots 12 and 13 on a plat of Wade Hampton Gardens, Section Two, and which said plat is recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book DDD, at Page 54, and according to a more recent survey made by H. C. Clarkson, Jr., dated October 22, 1965, having the following courses and distances, to-wit:

BEGINNING at an iron pin on the eastern side of Hampton Court in the line of Lot 13 and running thence with said Court, the chords of which are as follows: N. 27-57 W. 19 feet, N. 20-08 E. 40 feet and N. 22-45 W. 35 feet, to an iron pin on the edge of said Street, joint front corner with Lot 11; thence running with the line of said Lot N. 23-20 E. 142.1 feet to an iron pin; thence, S. 63-16 E. 130.75 feet to an iron pin; thence, S. 39-39 E. 50.7 feet to an iron pin in the line with Lot 12; thence running with the line of said Lot, S. 58-45 W. 160.2 feet to an iron pin; thence continuing with the line of said Lot, S. 58-45 W. 69.85 feet to an iron pin on the edge of Hampton Court, the point of Beginning.
