"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, on the Northeastern side of Dupont Drive being shown and designated as Lot 115 on a plat of ISAQUEENA PARK, a subdivision for Central Realty Corp., made by Pickell & Pickell, Engineers, dated June 3, 1947, and recorded in the RMC Office for Greenville County, South Carolina in Plat Book P, Pages 130 and 131, and having, according to said plat, the following metes and bounds, to-wit:
