WHEREAS the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose.

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargainest, sold, and released, and by those presents does grant, bargain, sell and release unto the Mortgagor its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, lying and being on the northeasterly side of Sutherland Hill Drive, near the City of Greenville, South Carolina being known and designated as Lot No. 162 on plat of Del Norte Estates as recorded in the RMC Office for Greenville County, South Carolina, in Plat Book WWW, pages 32 and 33 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeasterly side of Sutherland Hill Drive, said pin being the joint front corner of Lots 162 and 163, and running thence with the common line of said lots N. 37-24 E. 167.4 feet to an iron pin, the joint rear corner of Lots 162 and 163; thence S. 51-27 E. 90 feet to an iron pin, the joint rear corners of Lots 161 and 162; thence with the common line of said lots S. 38-23 W. 147.77 feet to an iron pin on the northeasterly side of Sutherland Hill Drive; thence with the northeasterly side of said Drive N. 57-00 W. 46 feet to an iron pin; thence continuing with said Drive N. 71-36 W. 44 feet to an iron pin, the point of beginning.
