MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

David R. Hatcher

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Dollars as evidenced by Mortgagor's promissory note of even date herewith which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain

One Hundred Fortyconditions), said note to be repaid with interest as the rate or rates therein specified in installments of

) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest computed monthly on unpaid principal bilances, and then to the payment of principal with the list payment if not sooner paid, to be due and payable eight years after date, and

WHEREAS said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and impaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due the rounder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortzagor may be reafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes insurance premiums, repairs, or for any other purpose:

NOW KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to score the payment thereof and any further sums which may be advanced by the Mortgagor in the Mortgagor's account, and also an consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor its successors and assigns, the following described real estate.

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Gantt Township, on the east side of Mayflower Avenue and being known and designated as Lot No. 17 of PECAN TERRACE Subdivision, plat of which is recorded in the RMC Office for Greenville County in Plat Book GG at Page 9, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Mayflower Avenue at the joint front corner of Lots Nos. 16 and 17 and running thence with the joint line of said Lots, S.80-48 E. 137.2 feet to an iron pin; thence S.17-35 W. 171.8 feet to an iron pin at the corner of Lot No. 18; thence with the line of said lot, N.38-03 W. 162.8 feet to an iron pin on the east side of Mayflower Avenue; thence with the east side of said Avenue, along a curve, the chord of which is N. 16 E. 60 feet to the beginning corner.
