"ALL that certain piece, parcel or let of land with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Grove Township, on the western side of Old Grove Road, containing 4.75 acres, being shown and designated as Lot No. 4 according to a plat entitled "Survey for John R. C., in Plats Book 6N, at Page 6, and having, according to said plat, the following metes and bounds, to-wit:
