TO ALL WHOM THESE PRESENTS MAY CONCERN

WHEREAS, I, David Ralph Masters

(hereinafter referred to as Mortgagor) is well and truly indebted unto Ruth C. Masters

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of

Greenville, situate, lying and being on the western side of Oak Hill Drive and being known and designated as Lots Nos. 16 and 17 of Section B of Oak Hills Subdivision, a plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book 141 at page 81, and having metes and bounds as shown thereon, reference to said plat being made for a more complete description.

This is a second mortgage on the above described property and junior in lien to that mortgage given to C. Douglas Wilson & Co. by Robert A. Flaspoebler and Yvette B. Flaspoebler in the original sum of \$23,500.00, and recorded in the R. M. C. Office for Greenville County in Mortgage Book 1303 at page 411.

The above described property is the same conveyed to the mortgagor herein by deed of Bill Pippen and Essie M. Pippen dated this date and to be recorded herewith.
