MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

conditions), said note to be repaid with interest as the rate or rates therein specified in installments of Two Hundred Nine

That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dollars (53.00) to the Mortgagor in hand well and tridy paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the south side of Hickory Lane, being shown and designated as Lot 63 on plat of Eastdale Subdivision recorded in the RMC Office for Greenville County, S. C., in Plats Book YY, at Pages 118 and 119, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the south side of Hickory Lane, joint corner of Lots 62 and 63, and running thence along the joint line of said lots 25 15-00 W 200 feet to an iron pin; thence S 75-00 E 100 feet to an iron pin; thence N 15-00 E 200 feet to an iron pin on Hickory Lane; thence along said Hickory Lane N 75-00 W 100 feet to an iron pin, the point of beginning.
