All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina. County of Greenville, being known and designated as Lot No. 42 of a subdivision known as River Downs, according to a plat thereof prepared by Piedmont Engineers, Architects and Planners, dated July 17, 1974, and recorded in the R.M.C. Office for Greenville County in Plat Book 4-R at Pages 75 and 76 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of the turnaround of Shetland Way at the joint front corner of Lots 42 and 43; running thence with the joint line of said lots 1S. 47-26 W. 215.40 feet to an iron pin at the corner of Lot 63; thence with the rear line of Lot 63 N. 51-15 W. 79.21 feet to an iron pin at the corner of Lot 64 N. 21-03 W. 115.00 feet nto an iron pin at the joint rear corner of Lots 41 and 42; thence with the joint line of said lots N. 82-13 E. 244.73 feet to an iron pin on the western side of the turnaround of Shetland Way; thence with the turnaround of Shetland Way, the chords of which are S. 8-36 E. 25 feet wand S. 38-19 E. 25 feet to the point of beginning.
