The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute; that the above described premises are free and clear of all liens or other encumbrances; that the Mortgagor is lawfully empowered to convey or encumber the same, and that the Mortgagor will forever defend the said premises unto the Mortgagor are successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

THE MORTGAGOR COVENANTS AND AGREES AS FOLLOWS:

- 1. That the Mortzagor will promptly pay the principal and interest on the indebtedness evidenced by sull promissory note at the times and in the manner therein provided.
- 2. That this mortgage will secure the Mortgagee for any additional sums which may be advanced bereafter, at the option of the Mortgagee, for the payment of taxes, or public assessments, hazard insurance prenouns, repairs or other such purposes pursuant to the provisions of this mortgage, and also for any loans or advances that may hereafter be made by the Mortgagee to the Mortgager under the authority of Sec. 45-55, 1962 Code of laws of South Carolina, as amended, or similar statutes, and all semis so advanced shall bear interest at the same rate or rates as that provided in said note unless otherwise agreed upon by the parties and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- 3. That it this mortgage secures a "construction loan", the Mortgager agrees that the press pid amount of the indebtedness hereby secured shall be distoursed to the Mortgagor in periodic payments, as construction progresses, in accordance with the terms and conditions of a Construction Loan Agreement which is separately executed but is under a part of this mortgage and incorporated herein by reference.

That the Meetz cor will not further encumber the premises above described, without the prior consent of the Mortgagee, and should the Mortgager so encumber such premises the Mortgagee may at its option, declare the indebtedness hereby secured to be numediately due and payable and may institute any proceedings necessary to collect said indebtedness.
- 9. That should the Mortzazor alternate the mortgaged premises by Contract of Sale, Bond for Title, or Deed of Conveyance, and the within mortgage indebtedness is not paid in full, the Mortgagor or his Furchaser shall be required to file with the Association an application for an assumption of the mortgage indebtedness, pay the reisonable cost as required by the Association for processing the assumption furnish the Association with a copy of the Contract of Sale, Bond for Title or Deed of Conveyance, and have the interest rate on the loan bidance existing at the time of transfer modified by ma reasing the interest rate on the said loan bidance to the maximum rate per annum permitted to be charged at that time by applicable South Carolina law, or a lesser increase in interest rate as may be determined by the Association. That should the Mortgagor fail to make payments of principal and interest as due on the promissory note and the same shall be unpaid for a period of thirty (30) days or if there should be my failure to comply with and abide by any by-laws or the charter of the Mortgagor, or any stipulations set out in this mortgage, the Mortgagor at its option may write to the Mortgagor at his last known address giving him thirty (30) days in which to rectify the said default and should the Mortgagor fail to rectify said default within the said thirty days, the Mortgagor, may at its option, more use the interest rate on the loin before for the remaining term of the loan or for a lesser term to the maximum rate per maxim permitted to be charged at that time by applicable South Carolina law, or a lesser increase rate as may be determined by the Association. That should the Mortgigor field to make payments of principal and interest as due on the promissory note and should any monthly installment become past due for a period in excess of 15 days, the Mortgiger may collect a "late charge" not to exceed an amount equal to five (5%) per centum of any such past due installment in order to cover the extra expense incident to the handling of such delinquent payments.
- 12. That the Mortgagor hereby assigns to the Mortgagee, its successors and assigns all the rents issues and profits accruing from the mortgaged premises retuning the right to collect the same so long as the debt hereby secured is not in arears of payment, but should any part of the principal indebtedness, or interest, tixes, or fire insurance premises, be past due and impaid, the Mortgagee may without notice or further proceedings take over the mortgaged premises, if they shall be occupied by a tenant or tenants, and collect said rents and profits actually collected, less the cost of collection, and my tenut is authorized upon request by Mortgagee, to make all rental payments direct to the Mortgagee without liability to the Mortgagor, the Mortgagee in an apply to the Mortgagee, and should said premises at the time of such default be occupied by the Mortgagor, the Mortgagee in an apply to the Mortgagee.
