All that certain piece, parcel, or lot of land with all improvements the rone or hereafter to be constructed thereon, situate, lying and being in the State of South Cardina, County of Greenville, being known and designated as Lot No. 24 of Wellington Green, Section II, as shown on plat thereof recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book YY, at page 117, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Imperial Drive, at the joint front corner of Lots Nos. 23 and 24 and running thence along Imperial Drive S. 58-08 E. 4 feet to an iron pin; thence, still with Imperial Drive, S. 52-13 E. 51.0 feet to an iron pin at the joint front corner of Lots Nos. 24 and 25; thence along the line of Lot 24, S. 32-26 W. 184.8 feet to an iron pin; thence N. 69-45 W. 100.0 feet to an iron pin at the joint rear corner of Lots Nos. 23 and 24; thence along the line of Lot No. 23, N. 31-52 E. 210.0 feet to the beginning corner.
