(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of -----
Forty-Nine Thousand Six Hundred and NO/100-----DOLLARS

(\$ 49,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

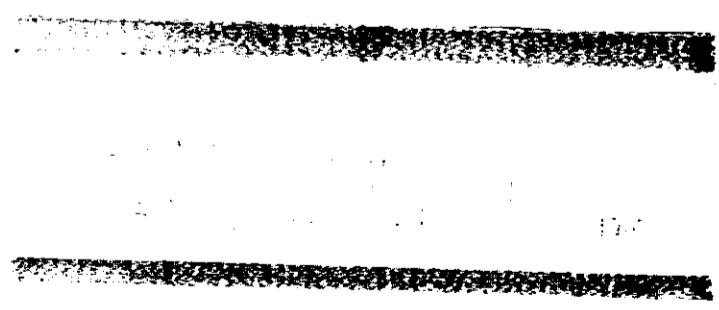
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Meadowbrook Drive, being known and designated as Lot No. 85 as shown on a plat BROOKSIDE, Section Three, recorded in the RMC Office for Greenville County in Plat Book 5-P at Page 11, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwestern side of Meadowbrook Drive, joint front corner of Lots 84 and 85 and running thence with the joint line of said Lots, N.67-48 W. 174.6 feet to an iron pin in line of Donald E. Baltz property; thence with the line of said property, N.09-26-12 E. 67.05 feet; thence N.46-30 E. 67.05 feet to an iron pin, joint rear corner of Lots 85 and 86; thence with the joint line of said Lots, S.56-15 E. 174.6 feet to an iron pin on the northwestern side of Meadowbrook Drive; thence with the northwestern side of said Drive, S.27-58-09 W. 91.9 feet to the point of beginning.
