Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter appared, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgager acceptants that he is lawfully seized of the premises hereinabove described in fee simple absolute that he has good right and lawful authority to sell, convey, or encumber the same, and that the premises are free and clear of all liens and encumbrances whatsoever. The Mortgagor further covenants to warrant and forever defend all and singular the premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- 1. That he will promptly pay the principal of and interest on the indebtedness evidenced by the said note, at the times and in the manner therein provided.
- 2. That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein, and also any further loans, advances, readvances or credits that may be made hereafter to the Mortgager by the Mortgagee; and that all sums so advanced shall bear interest at the same rate as the Mortgage debt and shall be payable on demand of the Mortgagee, unless otherwise provided in writing.
- 3. That the Martgagee may require the maker, as maker or endorser of any indebtedness secured hereby to carry life insurance upon houself in a sum sufficient to pay all sums secured by this mortgage, designating the Martgagee as beneficiary thereof, and upon failure of the Martgager to pay the premiums therefor, the Martgagee may, at its option, pay said premiums, and all sums so advanced by the Martgagee shall become a part of martgage debt.

That, together with, and in addition to, the monthly payments of principal and interest payable under the terms of the note secured hereby, he will pay to the Mortgagee, on the first day of each month, until the indebtedness secured hereby is paid in full, a sum equal to one-twelfth of the annual taxes, public assessments and insurance premiums, as estimated by the Mortgagee, and, on the failure of the Mortgagor to pay all taxes, insurance premiums and public assessments, the Mortgagee may, at its option, pay said items and charge all advances therefor to the mortgage debt. Any deliciency in the amount of such aggregate monthly payment, shall, unless made good by the Mortgagor prior to the due date of the next such payment, contribute an event of default under this mangage. The Mortgagee may collect a "late charge" on any installment which is not paid when due to cover the extra expense involved in handling delinquent payments. The schedule of "late charges" is as follows: 1st to 19th—no charge; 10th to 15th—50c; 18th to 20th—S1.60; after 20th—21; of payment. If, however, such monthly payments shall not be sufficient to pay such mens when the came shall become due and payable, then the Mortgagor shall pay to the Mortgagee any an our mesessary to make up the deficiency. Such payment will be made within thirty (30) days after written in the from the Mortgagee stating the mount of the deficiency, which notice may be given by mail.
- 7. That he hereby assigns all the rents, issues, and profits of the mortgaged premises from and after any definite from it.
