All that certain piece, parcel or lot of land with all improvements thereon or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as part of Lot 18 on plat recorded in the RMC Office for Greenville County in Plat Book M, Page 125, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Wildwood Road 190 feet south from the southwestern corner of Lee Road and Wildwood Road and running thence S 73-00 W 234.7 feet to a point in the center of a branch; thence down and with the center of said branch 40 feet, more or less, to a point where two branches intersect; thence down and with the center of this branch (the chord of which is S 23-39 E) 86.5 feet; thence N 73-00 E 268 feet to an iron pin on the westerly side of Wildwood Road; thence with said road N 17-00 W 110 feet to the point of beginning.
