

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagor for such further sums as may be advanced hereafter, at the option of the Mortgagor, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagor for any further sums, advances, revaluations or credits which may be made heretofore to the Mortgagor by the Mortgagor so long as the total indebtedness thereon and does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgaged debt and shall be payable on demand of the Mortgagor unless otherwise provided in writing.
- (2) That it will keep the property, at now existing or hereafter erected on the mortgaged property, insured as may be required from time to time by the Mortgagor, against loss by fire or by any other hazards specified by Mortgagor, in an amount not less than the mortgage debt, or such amount as is fully required by the Mortgagor, and in companies a capital sum equal to the amount that all such policies and renewals thereof shall be held by the Mortgagor until the date of final payoff, less payable clauses in favor of and in full receipt to the Mortgagor, and that it will pay all premiums therefor which shall be paid to the Lender assign to the Mortgagor the proceeds of any policies covering the mortgaged premises and does hereby authorizes each insurance company named to make payment for a loss directly to the Mortgagor, to the extent of the balance owing on the Mortgage debt, whether due or not.
- (3) That it will cause all workmen employed on the building or hereafter erected in good repair and, in the case of a construction loan, that it will continue to do so until the completion of the same, and should it fail to do so, the Mortgagor may, at its option, enter upon said premises, make whatever repairs are necessary including the completion of any construction work underway, and charge the expenses for such repairs or the completion of the same to the account of the Mortgagor.
- (4) That it will pay when due all taxes, public assessments and other governmental or municipal charges, fines or other impositions against the mortgaged premises. That it will comply with all governmental and municipal laws and regulations affecting the mortgaged premises.
- (5) That it hereby assigns all rents, issues and profits of the mortgaged premises, from and after any default, hereunder, and agrees that, should legal proceedings be instituted pursuant to this instrument, any judge having jurisdiction may, at Chambers or otherwise, appoint a receiver of the mortgaged premises, with full authority to take possession of the mortgaged premises and collect the rents, issues and profits, including a reasonable rental to be fixed by the Court in the event said premises are occupied by the Mortgagor and, after deducting all charges and expenses including such proceeding and the execution of its trust as receiver, shall apply the residue of the rents, issues and profits toward the payment of the debt secured hereby.
- (6) That if there is a default in any of the terms, conditions, or covenants of this mortgage or of the note secured hereby, then, at the option of the Mortgagor, all sums due, owing by the Mortgagor to the Mortgagor shall become immediately due and payable, and this mortgage may be foreclosed. Should any legal proceedings be instituted for the foreclosure of this mortgage, or should the Mortgagor become a party of any suit involving this Mortgage or the title to the premises described herein, or should the debt secured hereby, or any part thereof be placed in the hands of my attorney at law for collection by suit or otherwise, all costs and expenses incurred by the Mortgagor, and a reasonable attorney's fee, shall thereafter become due and payable immediately or on demand, at the option of the Mortgagor, as a part of the debt secured hereby, and may be recovered and collected hereunder.
- (7) That the Mortgagor shall hold and enjoy the premises above conveyed until there is a default under this mortgage or in the note secured hereby. It is the true meaning of this instrument that if the Mortgagor shall fully perform all the terms, conditions, and covenants of the mortgage, and of the note secured hereby, that then this mortgage shall be utterly null and void, otherwise to remain in full force and virtue.
- (8) That the covenants herein contained shall bind, and the benefits and advantages shall accrue to the respective heirs, executors, administrators, successors and assigns of the parties hereto. Whenever used the singular shall include the plural, the plural the singular, and the use of any gender shall be applicable to all genders.
