

C. Brissee as shown on a plat thereof recorded in R.M.C. Office for Greenville County in Volumn 00, Page 529 on September 7, 1940, No. 6658 by Carolina Engineering and Surveying Company, and having the following metes and bounds, to-wit;
	BEGINNING at an iron pin on the Northwest side of Hunt (Trotter) Street at the joint front corner of Lots Nos. 10 and 11, and runnging hence along the line of Lot No. 10, W. 55-30 W., 153 feet to an iron pin at the rear corner of said lot; thence N. 34-30 E. 25 feet to an iron pin at the center of Lot No. 11; thence on a line through the center of Lot No. 11 to an iron pin at the front center of Lot No. 11, S. 55-30 E. 153 feet; thence along the line of Hunt (Trotter) Street, S. 34-30 W. 25 feet to the point of BEGINNING.

	AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the said Note, when the same shall become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or intended to be secured hereby, shall forthwith become due, at the option of the said mortgages, its (his) heirs, successors or assigns, although the period for the payment of the said debt may not then have expired.
