with interest thereon from maturity at the rate of nine per centum per annum, to be paid: on demand.

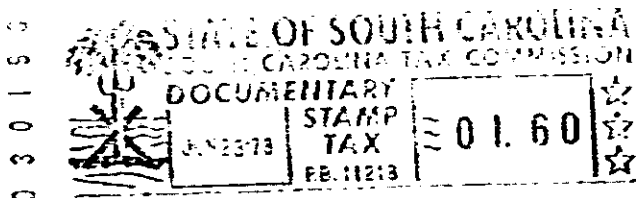

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Third Avenue and being known and designated as Lot No.107 on a plat of Section No. 1, Subdivision of Village Houses, F. W. Poe Hfg. Co., recorded in the RMC Office for Greenville County in Plat Book Y at Pages 26-31, and being more recently shown on a plat entitled "Property of Tom L. Sizemore and Robert H. Wynne, Jr.", prepared by Carolina Surveying Company, dated May 18, 1978, and recorded in the RMC Office for Greenville County in Plat Book 6-R at Page 18, and having such metes and bounds as shown thereon, reference to said plat being made for a more complete description.
