NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, On the eastern side of Wadewood Way, being shown as Lot No. 17 on a plat of Imperial Hills, made by C. C. Jones, Civil Engineer, dated August, 1964, and recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book BBB, at Page 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Wadewood Way, at the joint front corners of Lots No. 17 and 18, and running thence along the common line of said lots, N. 86-42 E. 157.7 feet to an iron pin; thence along the rear lines of Lots No. 23 and 24, S. 18-02 E. 140 feet to an iron pin; thence along the line of Lot No. 16, N. 78-46 W. 197.3 feet to an iron pin on Wakewood Way; thence along the eastern side of Wakewood Way, N. 1-35 W. 90 feet to an iron pin, the beginning corner.
