TO ALL WHOM THESE PRESENTS MAY CONCERN:

Ronald B. Funk and Wanda I. Funk (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty-two Thous and Six Hundred and no/100----- DOLLARS

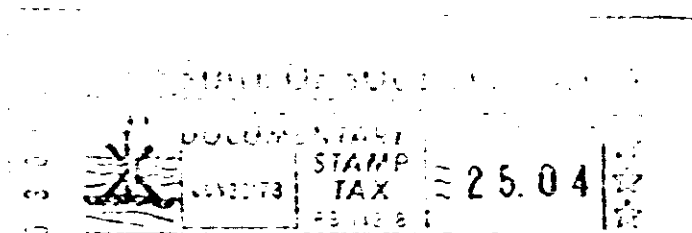

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 140 on plat of Sugar Creek, Section 1, recorded in Plat Book 5 D at page 72 and having the following courses and distances:
