WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of - Thirty-four thousand two hundred - - - - - - - - -

34,200.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, being shown and designated as Lot 14 on a Plat of THE CEDARS, recorded in the RMC Office for Greenville County in Plat Book 4-X, at Page 93, and having according to said Plat, the following metes and bounds:

BEGINNING at an iron pin on the southern side of Stonegate Road, joint front corner of Lots 14 and 15, and running thence with said Road, N 74-51 E, 65 feet to an iron pin; thence continuing with said Road, S 60-09 E, 35.3 feet to an iron pin on the western side of Tollgate Road; thence with said Tollgate Road, S 15-09 E, 83.2 feet to an iron pin; thence continuing with the curve of said Road, the chord of which is S 05-19 W, 29.8 feet to an iron pin; thence with the rear line of Lot 14, S 72-01 W, 117.9 feet to an iron pin, joint rear corner of Lots 15 and 15; thence with the common line of said Lots, N 15-01 W. 140 feet to an iron pin on the southern side of Stongegate Road, the point of beginning.

The is the same property conveyed to the Mortgagors herein by deed of Werber Co., Inc., recorded May 31, 1978, in Deed Book 1080, at Page 179.

"In addition to and togther with the monthly payments of principal and interest under the terms of the Note secuired hereby, the mortgagor promises to pay to the mortgagee a monthly premium necessary to carry private mortgage guaranty insurance until the principal balance reaches 80% of the original sales price or appraisal, whichever is less. The estimated monthly premium for the first nine years will be .02% of the original amount of the loan. The estimated monthly premium for each year thereafter will be .01% of the original principal balance of this loan. The mortgagee may advance this premium and collect it as part of the debt secuired by the mortgage if the mortgagor fails to pay it."
