
NOW, KNOW ALL MEN. That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being known and designated as Lot No. 60 of a Subdivision known as Canebrake I as shown on a plat thereof prepared by Enwright Associates, dated August 18, 1975 and revised October 6, 1975 and recorded in the Greenville County R.M.C. Office in Plat Book 5-D at Page 96, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northeastern side of Duquesne Drive, joint front corner of Lot Nos. 59 and 60 and running thence with the joint line of said lots N. 20-33 W. 141.73 feet to an iron pin in the rear line of Lot No. 50, joint rear corner of Lot No.s 59 and 60; thence running with the rear line of Lot No. 50 and continuing with Lot No. 49 S. 67-05 W. 64.00 feet to an iron pin on the rear line of Lot No. 49 S. 87-50 W. 28.40 feet to an iron pin on the rear line of Lot No. 60 and Lot No. 49 S. 87-50 W. 28.40 feet to an iron pin on the rear line of Lot Nos. 60 and 61; thence running with the joint line of Lot Nos. 60 and 61 S. 23-24 E. 168.98 feet to an iron pin on the northeastern side of Duquesne Drive, joint front corner of Lot Nos. 60 and 61; thence with said Drive in a northeasterly direction and arc distance of 85.29 feet to the point of beginning.
