(6) That if there is a default in any of the terms, conditions, or covenants of this mortgage, or of the note secured hereby, then, at the option of the Mortgagee, all suns then owing by the Mortgage to the Mortgagee shall become immediately due and payable, and this mortgage may be foreclosed.
