

ALL that lot of land situate on the southeastern side of Sugar Creek Road in the County of Greenville, State of South Carolina being shown as Lot No. 66 on a plat of Sugar Creek Subdivision, Map No. 5, dated June 8, 1977, prepared by C. O. Riddle, recorded in Plat Book 6-H at page 2 in the RMC Office for Greenville County and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Sugar Creek Road at the joint front corner of Lot 66 and Lot 67 and running thence with Lot 67 S 57-26 E 140 feet to an iron pin at the joint rear corner of Lot 66, 67, 78 & 79; thence with Lot 79 S 32-34 W 125 feet to an iron pin at the joint rear corner of Lot 65 and Lot 66; thence with Lot 65 N 57-26 W 140 feet to an iron pin on Sugar Creek Road; thence with said road N 32-34 E 125 feet to the point of beginning.
