(iii) requisitions signed by the architect supervising the restoration; (c) in the event the estimated cost of restoration exceeds the available insurance or condemnation proceeds, Nortgagee shall not be obligated to advance any proceeds until Nortgagor has expended a sum at least equal to the difference between the estimated cost of restoration and the available proceeds; (d) in the event the cost of restoration is less than the available insurance or condemnation proceeds, such excess proceeds shall be paid to Nortgagee to be applied against the outstanding principal of the loan.

Nortgagor shall carry and maintain such liability and indemnity insurance (including, but without limitation to, so called assumed and contractual liability coverage) as may be required from time to time by Mortgagee in forms, amounts and with companies reasonably satisfactory to Mortgagee. Certificates of such insurance, premiums prepaid, shall be deposited with Mortgage and shall contain provision for (10) days' notice to Mortgagee prior to any cancellation thereof.

Portgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained under this paragraph, unless l'ortgagee is included thereon as a named insured with loss payable to Mortgagee under a standard mortgagee endorsement. Portgagor shall immediately notify Mortgagee whenever any such separate insurance is taken out, specifying the insurer thereunder and full particulars as to the policies evidencing the same.
