NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

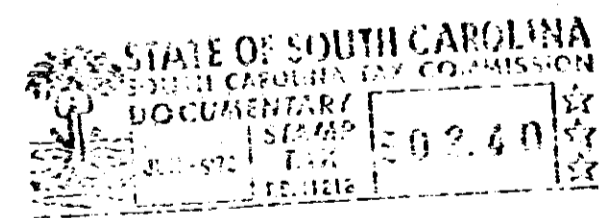
"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Bates Township, on the western side of Chestnut Ridge Road, being shown and designated according to a plat prepared by Terry T. Dill, Surveyor, dated April 10, 1979, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a point in the approximate center of Chestnut Ridge Road on the joint line of property now or formerly belonging to Hubert A. & Ruth B. Cash and the mortgagee herein, and running thence N. 64-22 W. 25 feet to an iron pin at the edge of the right-of-way of said road; thence continuing on the same course, 189 feet to an iron pin; thence N. 52-20 W. 180 feet to a point; thence N. 86-10 E. 241 feet to a point; thence S. 74-34 E. 130 feet to an iron pin at the edge of the right-of-way of Chestnut Ridge Road; thence continuing on the same course, 25 feet to a point in the approximate center of said road; thence down the approximate center of Chestnut Ridge Road S. 17-03 W. 181 feet to the point of beginning.

This being the same property conveyed to the mortgagor herein by deed of the mortgagee, to be executed and recorded of even date herewith.
