

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville
ALL that piece, parcel or lot of land with improvements thereon, situate, lying and being on the Eastern side of Vedado lane, in Greenville County, South Carolina, being shown and designated as Lot No. 40 and a small portion of Lot No. 39 on a Plat of Vardry-Vale, Section 2, made by Campbell & Clarkson Surveyors, Inc., dated March 17, 1969, and recorded in the RMC Office for Greenville County, S.C., in Plat Book Wall, page 53, and having, according to a plat of a revison of lots nos. 39 and 40 made by Campbell & Clarkson Surveyors, Inc., lated February 13, 1970, the following metes and bounds, to-wit

BEGINNING at an iron pin on the eastern side of Vedado Lane at the joint front corners of Lots Nos. 40 and 41, and running thence along the common line of said lots, S62-05E 157.8 feet to an iron pin; thence N27-13E 80.6 feet to an iron pin at the joint rear corners of Lots Nos. 39 & 40; thence a new line through Lot No. 39, N55-21W 174.8 feet to an iron pin on Vedado Lane; thence along the eastern side of Velado Lane, 102.5 feet to an iron pin, the beginning corner.

THIS being that property conveyed to Grantor by deed of Carla A. Hills, Secretary of Housing and Urban Development of Washington, D.C., recorded in the RMC Office for Greenville County in Deed Book 1044 at page 654 on October 15, 1976.
