THIS MORTGAGE is made this 15th day of May, 1979, between the Mortgagor, James Douglas Cox and Carla Harbin Cox (herein "Borrower"), and the Mortgagee, FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, a corporation organized and existing under the laws of SOUTH CAROLINA, whose address is 101 EAST WASHINGTON STREET, GREENVILLE, SOUTH CAROLINA (herein "Lender").

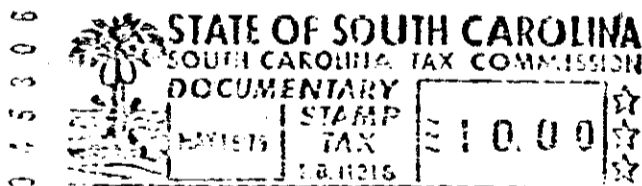
WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty Five Thousand and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated May 15, 1979 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on October 1, 2004.

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of _____, State of South Carolina:

All that piece, parcel or tract of land lying in the State of South Carolina, County of Greenville, shown as 1.14 acres on Survey for J. Douglas Cox, recorded in Plat Book 6 W at page 40 and having the following courses and distances appearing below:

Beginning at an iron pin on Ashmore Road at the joint corner of the within property and property now or formerly of Harbin and running thence S. 81-23 E. 306.7 feet to an iron pin; thence along the rear line of the within property, S. 10-00 E. 160 feet to an iron pin; thence N. 81-07 W. 357.2 feet to an iron pin on Ashmore Road; thence N. 8-25 E. 150 feet to an iron pin, the point of beginning.
